Connect NY Definitions:

Unserved Area

An area where broadband service is not available from a wireline or wireless facilities-based provider offering service at advertised speeds ≥ 6 Mbps download and 1.5 Mbps upload.

Underserved Area

An area where 50% or more of the households have no broadband service from wireline or wireless facilities-based providers offering service at advertised speeds ≥ 6 Mbps download and 1.5 Mbps upload.

Served Area

An area where more than 50% of the households have broadband service from wireline or wireless facilities-based providers offering service at advertised speeds ≥ 6 Mbps download and 1.5 Mbps upload.
