 - Tezera to do more research; Mary concerned that may not comply with NYS mandates regarding vitamins; May start slow & in small quantities
 - **QUESTION:** Will information be posted regarding diet specifications & produce? (E.G. Person on Coumadin not to eat foods with certain Vitamins). Feels there will be a need to post. Per Terry, Mary Richardson, the registered dietician, will handle.
