## Awarding Bid For Transportation Of Children With Disabilities

WHEREAS, Greene County's current contract for Transportation of Children with Disabilities is due to expire on August 22, 2014; and by Resolution No.194-14, adopted June 18, 2014, the Clerk of the Greene County Legislature was authorized to advertise for bids for transportation of children with disabilities; and

WHEREAS, the county tried to entice more bidders and two bids were received and fulfilled the specifications of the bid; and

WHEREAS, it is the County's desire to enter into contract with Johnston & Pulcher, Inc., 165 Main Street, PO Box 867, Philmont, NY 12565, effective September 1, 2014 for School Years 2014-2015, 2015-2016, 2016-2017 and Summer Sessions 2015-2016, 2016-2017 (September 1, 2014 through June 30, 2017) for the following routes at the following prices per vehicle round trip:

Route 1:	Advanced Therapy/Catskill Elementary	\$ 327.15
Route 4:	COARC/The Starting Place	\$ 394.50
Route 7:	Early Childhood Learning Center/Head Start Catskill	\$ 318.50
Route 9:	COARC/The Starting Place	\$ 224.75

- Additional children added to these routes will be at \$ 40.00 per day; and

WHEREAS, it is the County's desire to enter into contract with Coxsackie Transportation, Inc., effective September 1, 2014 for School Years 2014-2015, 2015-2016, 2016-2017 and Summer Sessions 2015-2016, 2016-2017 (September 1, 2014 through June 30, 2017) for the following routes at the following prices per vehicle round trip:

Route 2:	Circle of Friends-Ravena	\$ 435.00
Route 3:	Circle of Friends-Ravena	\$ 435.00
Route 5:	Center for Spectrum Services	\$ 295.00
Route 6:	Early Childhood Learning Center-Cairo	\$ 470.00
Route 8:	Early Childhood Learning Center-South Cairo	\$ 470.00

- Additional children added to these routes will be at \$ 60.00 per child round trip.
- Additional Bus Aide/Monitor/Attendant will be \$ 15.00 per hour - garage to garage.
- Fee for wheelchair vehicle with lift will be \$ 80.00 per day.
- Any additional locations, creating a new route, will be \$ 295.00 for the first child and \$ 60.00

per each additional child round trip;

NOW, THEREFORE, BE IT RESOLVED, that the County is authorized to enter into a contract for transportation services of children with disabilities with Johnston & Pulcher, Inc. and Cocksackie Transportation, Inc., subject to approval as to form by the Greene County Attorney, at the rates stated above, for School Years 2014-2015, 2015-2016, 2016-2017 and Summer Sessions 2015-2016, 2016-2017 (September 1, 2014 through June 30, 2017).
