## Setting Public Hearing On Greene County CSEA Local 820 - Unit 7000 Collective Bargaining Contract

WHEREAS, Greene County has been negotiating with Greene County Local 820 - Unit 7000 of the Civil Service Employees Association, Inc.; and

WHEREAS, no agreement could be reached, therefore the decision was made to go to fact finding; and

WHEREAS, the Greene County Legislature has received a report of the fact-finder dated December 9<sup>th</sup>, 2014, which has been filed in the office of the Clerk of this Legislature; and

WHEREAS, pursuant to Section 209.3 (e) (i.i.i.) of the Public Employees Fair Employment Act (Taylor Law), the Greene County Legislature will conduct a public hearing at which the parties shall be required to explain their positions with respect to the fact-finder report;

NOW, THEREFORE, BE IT RESOLVED, that this Legislature shall meet at 7:30 p.m. on the 21<sup>st</sup> day of January, 2015 at the Catskill High School Auditorium for the purpose of holding a Public Hearing to hear said explanations with respect to the fact-finder report; and

BE IT FURTHER RESOLVED, that the Clerk of the Legislature shall give notice of such Public Hearing in the manner prescribed by law.
