LOCAL LAW ON EXAMINATION, LICENSING

AND REGULATION OF ELECTRICIANS

SECTION 21. VIOLATIONS AND PENALTIES

1. Any person who shall directly or indirectly engage in or work a the business of Master Electrician, Special Electrician and Homeowner Electrician in the County of Greene without the applicable license or who, having had his license suspended or revoked, shall continue to engage in or work at the business shall be guilty of a class "A" misdemeanor and upon conviction thereof shall be punishable by a fine of not less than five hundred dollars (\$500.00) nor more than one thousand dollars (\$1,000.00) or imprisonment for a period not exceeding one (1) year, or by both fine and imprisonment.
