Amendments to the Bidding Documents

ITEM 1: Project Manual Cover:

CHANGE: "NYSDOT Contract....." to "NYSDOS Contract.....".

ITEM 2: Project Manual: Project Schedule; **CHANGE** references to the project schedule as found in various parts of the project manual to read as follows:

Section 001116 Notice to Bidders:

- **REPLACE:** "The project shall be substantially complete on or before June 15, 2017..." with "The project shall be substantially complete on or before July 14, 2017...."

Section 002115 Instruction to Bidders:

- 2.3.B.: **REPLACE:** "On or before June 15, 2017 all work as indicated..." with "On or before July 14, 2017 all work as indicated..."
- 2.3.B.: **REPLACE:** "Within twenty-one (21) working days from..." with "Within ten (10) working days from..."
- 2.3.D.: **REPLACE:** "Refer to Section 011400 Project Schedule & Phasing." with "Refer to Section 011100 Preliminary Schedule."

Section 003113 Preliminary Schedule:

- **REPLACE:** Section Number "003113" with Section Number "011100"
- 4.1.B.: **REPLACE:** "Substantial Completion 06.15.17" with "Substantial Completion 07.14.17"
- 4.1.B.: **REPLACE:** "Final Completion 06.29.17" with "Final Completion 07.28.17"

ITEM 3: Project Manual: Modify page numbers of Bid Forms on Bidder's Checklist.

Section Bidder's Checklist:

- **REPLACE:** "Bid Form (BF-1 to BF-3)" with "Bid Form (BF-1 to BF-2)"

ITEM 4: Project Manual: One sealed copy of Bids shall be required.

Section 001116 Notice to Bidders:

- **REPLACE:** "All bids shall be based on the Bid Specifications contained in the project manual, and shall be contained in a sealed envelope, submitted in duplicate, and distinctly marked..." with "All bids shall be based on the Bid Specifications contained in the project manual, and shall be submitted in a sealed envelope, distinctly marked..."

Section 002115 Instruction to Bidders:

- 4.3.B.: **REPLACE:** "All bids shall be submitted in duplicate." with "One copy of the submitted bid is required."

ITEM 5: Project Manual: M/WBE Requirements.

Clarification: The M/WBE project utilization goal of 10%/10% is based upon project value at completion of work.

NYSDOS Form D M/WBE Utilization Plan:

- **REPLACE:** "M/WBE Goals in the Contract: MBE 15% WBE 15%" with "M/WBE Goals in the Contract: MBE 10% WBE 10%".

ITEM 6: Project Manual: Allowances.

Clarification: Refer to AIA Document A201 – 2007 General Conditions of the Contract for Construction, Section 3.8 Allowances for information regarding overhead and profit associated with Allowances.

ITEM 7: Project Drawings: Sheet C-6.2, Detail 1.

Clarification: REPLACE: "Provide Continuous Rail Barrier and Extend 80'-0" as shown..." with "Provide Continuous Rail Barrier and Extend 147'-9" as shown..." Refer to Addendum No. 1 Sketch C-1B.

ITEM 8: Project Drawings: Sheet C-7.3, Detail 8.

Clarification: Stone seatwall cap stone width shall be a uniform 1'-10". The length of the cap stone pieces varies. Refer to Addendum No. 1 Sketch C-1C for minimum number of pieces of cap stone per wall.

ITEM 9: Project Manual: Work Restrictions.

Clarification: Refer to Addendum No. 1 Sketch C-1A for work limits and durations within the County parking lot.

ITEM 10: Project Drawings: Sheet C-3.2.

Clarification: REPLACE "Stones to be provided by Greene County, (TYP.)" with "Stones to be supplied to site by Greene County and installed by Contractor, (TYP.)"

ITEM 11: Project Manual: Porous unit pavers

Clarification: Acceptable unit pavers may include Aqua Roc II by “Belgard”, (877-235-4273), or approved equivalent.

ITEM 12: Project Manual: Granite stone supplier

Clarification: Acceptable granite stone manufacturers may include Champlain Stone, Fort Ann, NY, or approved equivalent.

ITEM 13: **ADD:** Addendum No. 1 is made part of the project bidding documents for construction of the Catskill Creek Waterfront Walkway dated 11.11.2016.
