The work involves the responsibility for planning and overseeing a comprehensive quality assurance program to ensure compliance with federal, state, and county mandated quality standards in all divisions of the Human Services Department. The incumbent performs a variety of compliance functions to ensure the agency is prepared at all times for audits and reporting deadlines. These functions include quality assurance, agency compliance, staff development, in-service training, client review, and services plan. The incumbent will conduct and coordinate policy review, development, and implementation subject to standards of best practices. The work is performed under the direct supervision of the Executive Director of Human Services with leeway permitted for the exercise of independent judgment in carrying out specific duties. Does related duties as required.

MINIMUM QUALIFICATIONS:

- **A.** Possession of a Bachelor's Degree in Nursing, Human Services, Healthcare Policy Management, or a health related profession, or risk management, <u>and</u> two (2) years full-time paid experience in the area of utilization review and/or healthcare policy management which may also include audits, quality assurance, risk management, and/or policy revision as it applies to federal or state programs; **OR**
- **B.** Graduation from a three (3) year school of professional nursing, <u>and</u> three (3) years of full-time paid experience in the area of utilization review and/or healthcare policy management which may also include audits, quality assurance, risk management, and/or policy revision as it applies to federal or state programs; **OR**
- **C.** Possession of an Associates Degree in Nursing, Human Services, Healthcare Policy Management, or a health related profession, or risk management <u>and</u> four (4) years of full time paid experience in the area of utilization review and/or healthcare policy management which may also include audits, quality assurance, risk management, and/or policy revision as it applies to federal or state programs; **OR**
- D. Graduation from high school or possession of an equivalency diploma with three (3) years' experience practicing as a current Registered Professional Nurse or six (6) years' experience practicing as a current Licensed Practical Nurse in a human services department or medical office setting and six (6) years of full time paid experience in the area of utilization review and/or healthcare policy management which may also include audits, quality assurance, risk management, and/or policy revision as it applies to federal or state programs.
