The incumbent will serve as a point of contact for families in need of community services. Work is performed under direct supervision of the Public Defender in accordance with outlined policies and procedures allowing for the exercise of independent judgment in planning and carrying out the details of the work. Does related work as required.

- **C.** Possession of Credentialed Alcoholism and Substance Abuse Counselor (CASAC) certification and three (3) years of full-time paid experience in counseling, social casework, or providing human services; **OR**
- **D.** An equivalent combination of training and experience as defined by the limits of (A), (B), or (C) above.
