AUTHORIZING CONTRACT FOR WINDOW WASHING WITH
NEW YORK STATE INDUSTRIES FOR THE DISABLED, INC. (NYSID)

Legislator offered the following resolution and
moved its adoption:

WHEREAS, the County was notified last year by NYSID that under New York State Finance Law Article XI Section 162, NYSID is entitled to a right of first refusal prior to the solicitation of competitive bids on certain services; and

WHEREAS, NYSID has submitted a cost proposal for the window washing services in the amount of \$5,302.83; and

WHEREAS, by law the County is compelled to award the contract to NYSID as NYSID appears on the New York State Office of General Services List of Preferred Source Offerings;

NOW, THEREFORE, BE IT RESOLVED, that the Chairman of the Greene County Legislature be authorized to execute an agreement, subject to approval as to form by the County Attorney, between Greene County and NYSID for window washing for the County office building and Courthouse in the total amount of \$5,302.83 (\$1,007.53 for the Courthouse and \$4,295.30 for the County office building at 411 Main Street, Catskill).
