Brief Description of Proposed Action (include purpose or need): The proposed action includes the installation of a ground mount 2596.16 Kw Photovoltaic Array System on a portion of land located on the above referenced property. The installation procedure is a direct push procedure, where utilizing a vehicle, posts are driven approximately 4' in depth every 12-16' and the solar panel racks are then mounted to the posts. An approximately 2 ft wide by 2 ft deep trench at the end of each row of panels which will house the electric line which is set to run, overhead from the array to a point approximately 20' past the bridge over the Shinglekill at which point it goes underground and will run towards Mountain Avenue where it will connect to a utility pole. The disturbance is limited to the temporary construction entrance, panel posts, fence and trenches at the end of the aisles as well as 3.48 +/- acres of tree removal.
