Establishing Capital Project #151 - Youth Fair Butler Building

WHEREAS, the Greene County Legislature has committed to building a Butler Building for the Greene County Youth Fair; and

WHEREAS, there is a need to create Capital Project #151 Youth Fair Butler Building; and

NOW, THEREFORE, BE IT RESOLVED, that the Greene County Treasurer be authorized to establish Capital Project #151 Youth Fair Butler Building and to establish the following accounts:

REVENUE:

H151 0000 5031 Inter-fund Transfers \$225,000.00

APPROPRIATION:

H151 0000 5197 Capital Project Expense \$225,000.00; and

BE IT FURTHER RESOLVED, that the Greene County Treasurer transfer \$50,000.00 from A 899.7310.1 (Youth Fair Butler Building) and \$132,990.89 from A 899.8160 (Solid Waste Bottle Deposits) currently in Fund Balance to Capital Project #151 Youth Fair Butler Building; and

BE IT FURTHER RESOLVED, that the Greene County Treasurer transfer an additional \$42,009.11 from A 899.8160 (Solid Waste Bottle Deposits) projected in Fund Balance between Fiscal Years 2024 and 2025 to Capital Project #151 Youth Fair Butler Building; and

BE IT FURTHER RESOLVED, that authorization is given to the County Administrator to arrange for Pre-Engineering services for this project, #151 Youth Fair Butler Building.
